

Any dog injured after closing date may have entry fee returned, less \$5.00 per entry by providing the trial secretary with a signed statement from a veterinarian at least ½ hour before judging begins.

NO ENTRY FEES will be returned if show cannot open or be completed by reasons of riots, civil disturbances, fire, act of God, public emergencies, act of public enemy, strikes, or any other causes beyond the control of the organizing committee ERRORS ON ENTRY BLANKS Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. There will be no refund for duplicated entries. We will make every effort to find all duplicate entries but if the entry has been processed, no refund will be made.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- 3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 4. Dogs listed in the **AKC Canine Partners[™] Program** may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT
