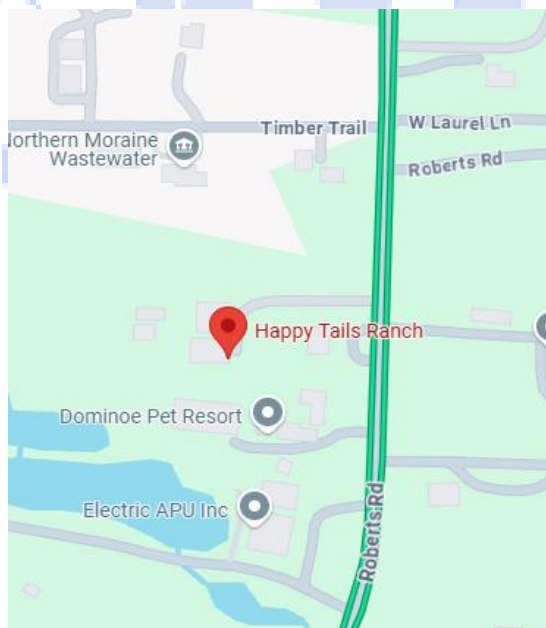

## **Additional Notice to Exhibitors**

The TRIAL SITE will be available to exhibitors from 7:30 am to 30 minutes after the trials are completed each day.

Building and rest rooms are handicapped-accessible.

Indoor crating is limited. Plan accordingly to crate out of your cars. Exhibitors are responsible for cleaning up after their dogs. Please deposit waste in provided containers.

No smoking permitted in the building.

RETURNED CHECKS does not constitute a valid entry fee.

ENTRY FEE shall not be refunded if a dog is absent, disqualified, excused by the veterinarian or judge or barred from competition by action of the Show Committee.

**BITCHES IN SEASON** Any bitch that comes into season after the closing date may have their entry fee returned, less \$5.00 per entry administrative fee without any veterinarian documentation. Any dog injured after closing date may have entry fee returned, less \$5.00 per entry by providing the trial secretary with a signed statement from a veterinarian at least ½ hour before judging begins.

**NO ENTRY FEES** will be returned if show cannot open or be completed by reasons of riots, civil disturbances, fire, act of God, public emergencies, act of public enemy, strikes, or any other causes beyond the control of the organizing committee

**ERRORS ON ENTRY BLANKS** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. There will be no refund for duplicated entries. We will make every effort to find all duplicate entries but if the entry has been processed, no refund will be made.

**ENTRIES Must Be Made On Official AMERICAN KENNEL CLUB ENTRY FORMS.** With the agreement printed on the reverse side, signed at the bottom by the owner or the owner's duly authorized agent, otherwise entry cannot be accepted.

**INSTRUCTIONS**

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine Partners<sup>SM</sup> Program** may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

**AGREEMENT**

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
